- 5. The tract boundary lines showing dimension, bearings, and corners.
- 6. The utilities, including sanitary and storm sewers, and other drainage features. Waterlines, gas mains, electric utilities are also to be shown on the plot plan.
- 7. The existing platting of adjacent land within 500 feet of the proposed work area.
- 8. Area subject to periodic overflow of floodwaters or stormwaters.
- 9. Other features or conditions which would affect the excavation, filling, or grading, favorable or unfavorable.
- 10. The title, graphic scale, North Point, and date.
- 11. Pennsylvania One Call Notification.
- 12. Certification by a registered architect, registered engineer, or registered land surveyor.
- 13. An Erosion and Sedimentation Control Plan per the Allegheny County Conservation District, prepared by a registered engineer, registered architect, or a registered land surveyor.
- 14. A Stormwater Management Plan, per local code, prepared by a registered engineer, registered architect, or a registered land surveyor.
